# Proposed Minutes of January 11, 2016

The Ossineke Township Board met in regular session, at the Ossineke Twp. Hall. Supervisor Lobert called the meeting to order, at 7:00 p.m. The Pledge of Allegiance was recited. - 2. The Treasurer reported balances on hand as of January 1, 2016 as follows: \$599,676.16 in the General Fund, \$1372.98 in the Liquor Fund: \$72,216.34 in the Fire Protection & Equipment Fund, and \$119,246.19 in Trust and Agency.

Kevin Grulke commented on the way the County is snow plowing Bushey road. He said there are places that 2 vehicles would have a tough time passing each other.
