Ossineke Township – Zoning Ordinance Amendment

On November 10, 2018, the Ossineke Township Board of Trustees adopted Ordinance 1 of 2018 containing zoning ordinance amendments relating to solar energy which take effect on November 22nd, 2018. The full text of the amendments is available on http://ossineketownship.com or at the Ossineke Township Hall at 9041 W. Nicholson Hill Road, Hubbard Lake, Michigan. The amendments modify the Ossineke Township Zoning ordinance as follows: Amend Section 2.1 (definitions) to add definitions for solar energy facility (utility-scale) and solar energy panels (accessory). Amend Section 4.0 (Table of Permitted and Special Land Uses) to add solar energy facility (utility-scale) as permitted use in FF-1 and to add solar energy panels (accessory) as a permitted use in all districts. Amend Article 7 to add Section 7.27A Solar Energy Facilities (Utility Scale) and Section 7.27B Solar Energy Panels (accessory) containing supplemental regulations for each.
